Government Response
To Defense Motion to Compel Production
of Witnesses

23 February 2016

1. Timeliness

The Prosecution timely files this Response pursuant to Military Commissions Trial Judiciary Rule of Court ("R.C") 3.7.

2. Relief Sought

The Prosecution respectfully requests the Commission deny the requested relief contained within AE 152OO (RBS), Mr. Binalshibh's Defense Motion to Compel Production of Witnesses, without oral argument.

3. Burden of Proof

As the moving party, the Defense must demonstrate by a preponderance of the evidence that the requested relief is warranted. R.M.C. 905(c)(1)-(2).

4. Facts

On 11 December 2015, Defense counsel for Mr. Binalshibh filed AE 152LL (RBS), an Emergency Motion for Show Cause Why The Government, JTF Camp Commander and JTF Guard Force Members Should Not be Held in Contempt. Within its motion, the Defense requested that this Commission "order the Government, the Camp VII Commander, the Joint Detention Group (JDG) Commander and the Joint Task Force (JTF) guard force to comply with its orders in AE 152HH, or show cause why the Government should not be held in contempt for

interfering with Mr. Binalshibh's rights to assistance of counsel and to present a defense."

AE 152LL (RBS) at 1. The Accused alleged that JTF-GTMO guard force members continued to violate the Commission's order and have caused noise and vibrations in his cell. *Id.* at 4-5.

However, in make his allegations, the Accused cited no independent evidence that supported his false sense of reality.

On 28 December 2015, the Prosecution timely responded and filed AE 152MM (GOV), requesting that the Commission "deny without oral argument the requested relief contained within AE 152LL (RBS)" AE 152MM (GOV) at 1. In doing so, the Prosecution unequivocally stated that "the Government has conducted its due diligence in this matter and there is once again absolutely no credible evidence of JTF-GTMO guard force personnel intentionally harassing Mr. Binalshibh with noises or vibrations in any way." *Id.* at 2. It further noted that Mr. Binalshibh's "complaints have been extensively investigated by the JTF-GTMO personnel and found to be without merit." *Id.* at 2 (citing AE 152BB (GOV), Attachment E, Declaration of Former Camp Commander. The Prosecution incorporates by reference the facts and arguments it advanced in AE 152MM (GOV).

On 20 January 2016, Defense counsel for Mr. Binalshibh submitted a request to the Prosecution to interview certain witnesses.. AE 152OO (RBS), Attachment C. Within it, the Defense requested to interview the following individuals:

- a. The Watch Commander, [REDACTED] on Mr. Binalshibh's tier in Camp 7 [REDACTED]
- b. The Watch Commander, [REDACTED] on Mr. Binalshibh's tier in Camp 7 [REDACTED]
- c. The Watch Commander, [REDACTED] on Mr. Binalshibh's tier in Camp 7 [REDACTED]
- d. The Watch Commander, [REDACTED] on Mr. Binalshibh's tier in Camp 7 on [REDACTED]
- e. All other guard force personnel whose duties pertain to detainees at Camp 7 and who have knowledge about the noise and vibrations complained of by

Mr. Binalshibh or who have had conversations with Mr. Binalshibh regarding the noise and vibrations; and

f. Camp 7 ISN 10016 and ISN 10023.

Id., Attachment C. The Defense asserted that the above-named witnesses were relevant and necessary to demonstrate Mr. Binalshibh's allegations contained in AE 152LL (RBS) were true.

On 5 February 2016, the Prosecution responded to the Defense request and stated that with regard to the Watch Commanders identified in its request, each of them declined to speak with Defense counsel. *See* AE 152OO (RBS), Attachment E at 2-6. Further, the Prosecution asserted that with regard to category (e), the Defense request was overbroad. Last, the Prosecution agreed to make available for interview Camp 7 ISN 10016 and ISN 10023 provided the respective detainees agreed and their counsel, if represented, consent to such an interview. *Id.*, Attachment E at 2. On information and belief, the Defense counsel have, in fact, met with these two detainees to interview them.

On 9 February 2016, the Defense filed the instant motion (AE 152OO (RBS)) and requested "the Military Judge compel the production of guard force personnel identified as '1629 Watch Commander,' '1559 Watch Commander,' '1604 Watch Commander,' and 'MP Badge #1609,' whose duties pertain to the detention of [Mr. Binalshibh] in Camp 7, for the hearing to be held from 16-26 February 2016, regarding AE 152LL." AE 152OO (RBS) at 1. Defense counsel for Mr. Binalshibh asserted that they "need[] to examine these witnesses in support of this motion [(AE 152LL (RBS))] as counsel have reason to believe the requested witnesses have knowledge of the continued harassment inflicted upon [Mr. Binalshibh]." AE 152OO (RBS) at 1-2.

5. Law and Argument

I. The Defense Is Afforded Access to Witnesses in a Manner Consistent With the Law

As an initial matter, within the context of this Military Commission, the universe of potential witnesses, and the information they hold, span a continuum of sensitivity. It is for this

reason, the Office of the Chief Prosecutor has crafted and utilized protocols for Defense access to potential witnesses for pretrial discovery interviews that reflect the law as well as the relative sensitivity of each type of witness. *See* AE 342 (WBA), Attachment C. Despite these established lawful protocols, the Defense claim that “[t]he Government is interfering with [Mr. Binalshibh’s] right to access and attempt to interview witnesses to AE 152LL” AE 152OO (RBS) at 4. Specifically, the Defense asserts that “[t]he defense needs to see these witnesses in person, speak with these witnesses, and must be provided the opportunity to explore whether the witness will speak with the Defense counsel.” *Id.* at 4-5.¹ In doing so, however, the Defense fails to address the national security issues associated with these witnesses, to include, the highly-classified information they undoubtedly possess. Where the Government, as well as this Commission, has a strong interest in preventing the unauthorized disclosure of classified information, *see* 10 U.S.C. § 949p-1(a), this Commission must conclude that the Government’s adherence to the procedures contained within the Government’s Bench Brief on Defense Access to Witnesses, *see* AE 342 (WBA), Attachment C, was lawful and appropriate under the circumstances.

In fulfilling its duties, the Prosecution must take all necessary steps to ensure that official government or classified information is adequately protected throughout the course of these proceedings, including during interviews. The Government’s Bench Brief on Defense Access to Witnesses establishes procedures/protocols in order to assist the Prosecution in accomplishing this mission while at the same time balancing the Defense right to access potentially relevant witnesses who possess official and/or classified information and who are, or were, employed in a sensitive government position. Under these established protocols, once the Defense

¹ In advancing their argument, the Defense cites to *United States v. Scott*, 518 F.2d 261 (6th Cir. 1975) for the proposition that “[t]he defense is entitled ‘to have access to any prospective witness’ including the right to attempt to interview a witness” and that “[t]his right to access is guaranteed regardless of whether the ‘access may not lead to an actual interview.’” AE 152OO (RBS) at 4 (citing *Scott*, 518 F.2d at 268). However, the Defense ignores that the 6th Circuit Court of Appeals also stated within that same paragraph that “[c]ertainly, the prosecution has no right to interfere with or prevent a defendant’s access to a witness (*absent any overriding interest in security*).” *Scott*, 518 F.2d at 268 (emphasis added).

demonstrates that the requested witness's expected testimony would be noncumulative, relevant and helpful to the material preparation of the defense, the Government will contact the witness, or the witness's relevant agency, and advise the witness of his/or her rights pertaining to the interview, as occurred here. *See id.*, Attachment C at 22. For those witnesses who decline to speak with the Defense, the Government will dutifully report their response, as it has done here. *See id.*, Attachment C at 23; *see also* AE 152OO (RBS), Attachment E. Despite Defense assertions to the contrary, these procedures are entirely permissible under R.M.C. 701, as well as federal and military case law, and were, in fact, adopted by the Military Judge in *United States v. Abd Al Hadi Al-Iraqi*. *See* AE 029B, Ruling on Access to Witnesses.

Indeed, the military commission case of *United States v. Hadi Al-Iraqi* is the context in which the issue of Defense access to potential JTF-GTMO personnel has been addressed most clearly. In that case, the Military Commission concluded that the procedures as outlined above and the Government's Bench Brief, in toto, are consistent with all governing law. Specifically, the Military Judge found that while recognizing that "[c]ourts have held that defense access to witnesses may only be impeded due to the most compelling of circumstances," AE 029B at 3 (citing *United States v. Cook*, 608 F.2d 1175, 1180 (9th Cir. 1979)),² "the protection of sensitive, official or classified information *is a compelling reason* to establish procedures for regulating defense access to witnesses possessing this information." AE 029B at 3 (emphasis added). With this in mind, the Military Judge declared that "the procedures proposed by the Prosecution allow Defense counsel reasonable access," and are "permissible within R.M.C. 701, as well as federal and military case law." AE 029B at 4.

While the Defense may wish to assert that the Government is somehow impeding their access to purportedly relevant witnesses to the instant motion, *see* AE 152OO (RBS) at 4-5, there is absolutely no evidence of this occurring, because it simply did not occur. In the present case,

² *See also* AE 152OO (RBS) at 5 (arguing that "[t]he Government would be required to put forth a very compelling circumstance that would support such a denial and interference with Mr. Binalshibh's right to access witnesses.")

and in accordance with the Government's Bench Brief on Defense Access to Witnesses, *see* AE 342 (WBA), Attachment C, the Government appropriately inquired of each of the Defense's requested witnesses whether they would voluntarily consent to a pretrial interview with the Defense. *See* AE 15200 (RBS), Attachment E. And in each case, the requested witness respectfully declined. While the Defense may wish the Government to compel a witness to agree to a pretrial interview, there is no mechanism within statute or case law that would even grant the Government the authority to do so. Absent such a mechanism, it is within the right of the witness to refuse a pretrial interview, as was the case here.

II. The Prosecution Will Produce Any Available Witness Whose Testimony Would Be Relevant and Necessary

Among the many protections provided to an accused facing trial by military commission is the right to obtain witnesses. The Military Commissions Act of 2009 (hereinafter "M.C.A") provides the Accused a reasonable opportunity to obtain witnesses and other evidence as provided in regulations prescribed by the Secretary of Defense. *See* 10 U.S.C. § 949j. The Secretary of Defense, in turn, promulgated the Manual for Military Commissions (hereinafter "the Manual"), which contains the Rules for Military Commissions (hereinafter "R.M.C."). The procedures contained in the Manual are based upon the procedures for trial by general courts-martial under Chapter 47 of Title 10 (the Uniform Code of Military Justice). *See* R.M.C. 102(b).

Among the rules issued by the Secretary of Defense in the Manual is R.M.C. 703 (Production of Witnesses and Evidence). R.M.C. 703 is directly patterned after Rule for Courts-Martial (hereinafter "R.C.M.") 703, the rule followed in courts-martial practice by the United States military, and provides the Accused in this case with the same safeguards afforded to members of our Armed Forces. *See* Ruling, AE 036C at 4-6 (citing *United States v. Arias*, 3 M.J. 436 (C.M.A. 1977); *United States v. Williams*, 3 M.J. 239, 243 (C.M.A. 1977); *United States v. Dixon*, 8 M.J. 858 (N.M.C.M.R. 1980)). The Rule provides that "[e]ach party is entitled to the production of any available witness whose testimony on a matter in issue on the merits or on an interlocutory question would be relevant and necessary." R.M.C. 703(b)(1). In doing so,

it also requires the Defense to give the trial counsel a written list of witnesses they want and to provide contact information as well as a synopsis of the expected testimony sufficient to show each witness' relevance and necessity. *See* Ruling, AE 036C at 4-5 (citing R.M.C. 703(c)(2)). The Prosecution takes its obligations seriously under R.M.C. 703, and will produce defense witnesses upon an adequate showing of relevance and necessity pursuant to the Rule.

Testimony is *relevant* "when a reasonable person would regard the evidence as making the existence of any fact that is of consequence to the determination of the commission action more probable or less probable than it would be without evidence." M.C.R.E. 401. Military jurisprudence has further recognized that relevant testimony is only *necessary* "when it is not cumulative and when it would contribute to a party's presentation in some positive way on a matter in issue." *See* R.C.M. 703(b)(1) Discussion; *see also* R.M.C. 703(f)(1) ". . . [s]ubject to § 949j(c) and R.M.C. 701, each party is entitled to the production of evidence which is relevant, necessary and noncumulative"); M.C.R.E. 403 ("the military judge shall exclude any evidence the probative value of which is substantially outweighed . . . by considerations of undue delay, waste of time, or needless presentation of cumulative evidence.).

The Accused has no right to compel the attendance of witnesses whose testimony would be cumulative with other evidence already available to the Defense and which would better and more directly address the interlocutory question at issue. *See United States v. Williams*, 3 M.J. 239, 243 (C.M.A. 1977); *see also United States v. Harmon*, 40 M.J. 107, 108 (C.M.A. 1994); *Wagner v. United States*, 416 F.2d 558, 564-65 (9th Cir. 1969), *cert. denied*, 397 U.S. 1015 (1970); *Thompson v. United States*, 372 F.2d 826, 828 (5th Cir. 1967); *United States v. Tangpuz*, 5 M.J. 426, 429 (C.M.A. 1978) (Court of Military Appeals identified numerous factors that may be considered in determining whether the accused is entitled to the attendance of a witness, including whether the witness' testimony would be "merely cumulative"); *United States v. Allen*, 31 M.J. 572, 610-11 (N.M.C.M.R. 1990).

III. The Requested Witnesses Are Unnecessary to the Commission's Resolution of AE 152LL (RBS) or the AE 152 Motion Series

This Commission should not continue to allow the Defense counsel to waste the resources of the United States Government litigating the continuous unfounded claims made by Mr. Binalshibh. These complaints have been extensively investigated by JTF-GTMO personnel and found to be completely without merit. *See* AE 152BB (GOV), Attachment E, Declaration of Former Camp Commander. Despite Defense counsel's best efforts, there will be no U.S. Government witness the Defense will be able to call that will testify to the contrary, because what Mr. Binalshibh is alleging is simply not occurring.

Based on records available to the Prosecution, and which have been provided to the Defense, at no time has JTF-GTMO personnel purposely caused "disruptive or harassing noises and vibrations in the Camp where [Mr. Binalshibh] is detained." AE 152HH. Further, at no time, during the periods alleged, do the records imply that JTF-GTMO guard staff told Mr. Binalshibh that the guard did not have to comply with this Commission's order, and there is no evidence that they threatened Mr. Binalshibh with retaliation should Mr. Binalshibh make a complaint against guard staff. Instead, as demonstrated throughout the DIMS records provided to Defense counsel, JTF-GTMO guard staff have acted appropriately and professionally in every instance where Mr. Binalshibh has complained of disturbances.

As the attached timeline of 60 plus instances³ illustrates, despite the foul-mouthed, misogynistic and hateful threats made by Mr. Binalshibh to the guard force, the guards acted professionally and indicated to him, on numerous occasions, that they were aware of the Military Judge's Order, that they were following that order, and that they would pass along his complaints. Unless the Defense counsel can articulate that the witnesses, if called, would testify to something other than what is in the official statements of these active-duty guards as reflected

³ As reflected in the DIMS reports dating from October 2015 to the beginning of December 2015. Attachment B is being offered as an unclassified summary of voluminous writings pursuant to M.C.R.E 803(a); M.R.E. 1006. It is unclassified because it does not list the dates, guards, and incidents together in a way that could reveal techniques, tactics, and procedures of the guard force and its rotations.

in the DIMS records, the requested witnesses would not “contribute to [the Defense’s] presentation in some positive way on [the] matter in issue.” *See* R.C.M. 703(b)(1) Discussion. As such, this Commission should deny the Defense motion.

No matter how many hours the Commission spends on this issue and no matter how many witnesses may testify, Defense counsel will not and cannot prove that what Mr. Binalshibh is alleging is actually occurring, because it is not occurring. This is not because “[t]he Government is interfering with Mr. Binalshibh’s right to access and attempt to interview witnesses . . . ,” AE 152OO (RBS) at 4, but, rather, because what Mr. Binalshibh has alleged from 2006 to present is not, in reality, occurring. *See* AE 152BB (GOV), Attachment B, Declaration of Doctor #1.

Of course, Mr. Binalshibh is free to request that JTF-GTMO doctors evaluate him, and if medically appropriate, prescribe him the medication he was on previously to control these sensations. As set forth in Prosecution Exhibit AE 152W, pages 63-125, and AE 152BB (GOV), Attachment B at 17, a timeline of his medical care and frequent complaints establish that Mr. Binalshibh responds well to the medications, and there “appears to be a correlation between his taking the medication and the frequency and nature of his complaints.” *See* AE 152BB (GOV) at 17.

6. Conclusion

As stated previously, the Prosecution takes its obligations under R.M.C. 703 seriously and will produce any witness requested by the Defense that is both relevant and necessary to a matter in issue before this Commission. However, where the Defense cannot establish that the requested witness would contribute to their presentation in some positive way on the matter in issue, the Prosecution will dutifully object, as it has done so in the instant response. The Prosecution further believes that this Commission should also immediately deny without further evidentiary hearing or oral argument, the Defense’s requested relief under AE 152LL (RBS) and AE 152F (RBS). As there is absolutely no evidence available indicating that what
