For a Trial Scheduling Order and Notice of Status of Discovery

12 December 2014

1. The Prosecution requested the Commission establish a Trial Scheduling Order, anticipating starting the trial on 22 September 2014, and providing as a basis for their motion "[t]his case is entering a new phase as the Prosecution's anticipated discovery is nearly complete, and a firm trial scheduling order must now be set so the parties can properly plan for trial." Defense response challenged the status of discovery and "the imposition of its artificial and virtually impossible litigation schedule." In

April 2014, the Prosecution provided the Commission an update on the status of discovery.³

- 2. On 24 July 2014, concerned about inordinate delays attributable to issues impacting only the case against Mr. bin al Shibh, the Commission issued an Order⁴ severing the case of *United States v. Ramzi Bin al Shibh* from the cases of *United States v. Khalid Shaikh Mohammad, Walid Muhammad Salih Mubarak Bin 'Attash, Ali Abdul Aziz Ali,* and *Mustafa Ahmed Adam al Hawsawi*. The Prosecution, acknowledging the delay inherent in resolving the issues leading to the Severance Order, requested the Commission hold the severance in abeyance.⁵ The Prosecution motion was Granted⁶ thereby causing delay in these proceedings.
- 3. The Commission finds the request of the Prosecution to issue a meaningful Trial Schedule Order is not within the realm of possibility at this juncture given the delays involved with the Emergency Joint Defense Motion to Abate Proceedings and Inquire into Existence of Conflict of Interest Burdening Counsel's Representation of Accused, the Government Motion For R.M.C. 909 Hearing in April 2014 and Direct Inquiry by the Military Judge to Mr. bin al Shibh Regarding His Capacity to Stand Trial By Military Commission and the Emergency Defense Motion To Order the Cessation of External Use of Sounds and Vibrations to Interfere with Mr. Bin al Shibh's Confinement and with the
