 Binalshikh, Ali Abdul Aziz Ali and
 Mustafa Ahmed Adam al Hawsawi
 wanted to meet me.

I want to affirm to you and to them
 my willingness and readiness
 to meet them at any time or
 place they find appropriate.

I have in the past written to this

Military Commission to make my testimony available on the 14th of 9 Saudi Prince Turki, Princess Hanifa and Omar AlBayan.

For many years Supermax War den and staff have engage in a vicious and constant campaign to "break" me psychologically and physically. (I have an hernia and my scheduled surgical operation was cancel by ADX.)

So it is very important that under no circumstance you should believe the BOP ADX if they were to claim that I ~~refuse~~ refuse to see you I will see you, the lawyer of KSM no matter what.
