1. On 3 April 2019, the Commission issued a Ruling in AE 524LLL in which it set a timeline for Defense Teams seeking to move the Commission to suppress statements made by the Accused to the Federal Bureau of Investigation.<sup>1</sup>

2. Thereafter, Counsel for Messrs. bin al ‘Shibh,<sup>2</sup> Hawsawi<sup>3</sup>, bin ‘Attash,<sup>4</sup> and Mohammad<sup>5</sup> filed pleadings with the Commission requesting various extensions to the timelines set forth in AE 524LLL Ruling (as well as other relief in the AE 524 Series).

**3. Ruling and Order.**

a. Mr. bin al Shibh’s Motion for Extension of Time to File a Motion to Suppress is **GRANTED IN PART**. Accordingly, Mr. bin al Shibh is granted a 30-day extension of time in which to file his suppression motion, with said motion due to be filed on or before **10 June 2019**.

b. Counsel for Messrs. Mohammad, bin ‘Attash, and Hawsawi are granted until **15 May 2019** to file individual, particularized motions requesting specific extensions of time in

which to file their suppression motions. Said motions for extension of time shall only address the need for the extension, and shall not be filed using Appellate Exhibit (AE) 524 Series designators. Instead, they shall be filed using new AE designators specific to each Defense Team.<sup>6</sup>

c. Motions for extension of time in which to file suppression motions in accordance with this Ruling shall not be subject to the automatic joinder provisions of Military Commissions Trial Judiciary Rule of Court 3.5 i. Likewise, any granting of a request for extension of time in which to file a suppression motion shall apply only to the individual defense team making the request.
