Pursuant to Commission Rulings  
AE 530GGG and AE 530PPP  
(Laptop Examination)

Filed: 18 April 2019

1. **Timeliness:** This Notice is timely filed.
2. **Facts:**
  - a. In AE 530GGG<sup>1</sup>, the Commission denied the Government's motion for reconsideration, which sought an order for Mr. al Hawsawi's laptop to be examined by the Government. *See* AE 530GGG, at 5.
  - b. The Commission ruled that

Mr. Hawsawi's computer will be returned to him upon his certification to the Commission that (1) the laptop seized from him have [sic] been forensically examined by Defense Information Technology personnel; (2) the forensic examination revealed no manipulation of the laptops [sic] to circumvent disabled capabilities; and (3) any internet or other communication enabling features have been disabled, the Commission will order return of the laptop to Mr. Hawsawi. This certification shall be served on the Commission and all the parties and will not be filed *ex parte* or under seal.
