1. Timeliness

The Prosecution respectfully requests to withdraw AE 538O (GOV Sup)/AE 561J (GOV Sup) due to an administrative error by with regard to the provided filing designation.

4. Facts

On 22 April 2019, the Trial Judiciary notified the Prosecution that there had been an administrative error with the provided filing designation.

5. Law and Argument

The Prosecution respectfully requests to withdraw AE 538O (GOV Sup)/AE 561J (GOV Sup). If this request is granted, the Prosecution will re-file an identical pleading seeking the same relief under a new filing designation in the AE 538/AE 561 motion series.

6. Oral Argument

The Prosecution does not request oral argument.

7. Witnesses and Evidence

The Prosecution will not rely on any witnesses or additional evidence in support of this motion.

8. Conference with Opposing Party

Based on the nature of the administrative error, the Trial Judiciary indicated on 22 April 2019 that the requirement for conference under R.C. 3.5.k has been waived for this motion.
