**Mr. al Baluchi's Motion to Dismiss**  
For the Government's Denial of a Public Trial

2 February 2018

**1. Timeliness:** This motion is timely filed pursuant to Military Commissions Trial Judiciary Rule of Court 3.7.c(1) and Rule for Military Commission (R.M.C.) 905(b).

**2. Relief Sought:** Mr. al Baluchi respectfully requests that the military commission dismiss the charges against him, brought under the Military Commissions Act of 2009 (2009 MCA), because the government has failed to provide a public trial.

**3. Overview:** In 2012, Mr. al Baluchi first alerted the military commission that the government was denying his right to a public trial.<sup>1</sup> At that time the government promised to make improvements.<sup>2</sup> Now, six years later, the government's scheme for providing a public trial has proven to be a dismal failure. The general public continues to face the logistical difficulty (or impossibility) of traveling either to a single remote viewing site or to Naval Station, Guantanamo Bay, Cuba, to watch the proceedings. Since 2013, with one exception, the government has not released redacted transcripts of classified hearings to the public. In 2017, the government released

zero redacted versions of classified pleadings to the public. Likewise, the government has not released a significant portion of unclassified pleadings to the public at all. When the government releases unclassified pleadings, it does not do so in a timely manner. The result is a trial that is not meaningfully open to the public, and the military commission should therefore dismiss the charges.

**4. Burden of Proof:** Ordinarily the moving party must demonstrate by a preponderance of the evidence that the requested relief is warranted.<sup>3</sup> However, given the strong and long-standing presumption in favor of public trials,<sup>4</sup> the burden of justifying a limitation upon public access must rest upon the party seeking such limitation.<sup>5</sup> Consequently, the burden of persuasion must rest upon the government.

**5. Facts:**

- a. There have been a total of sixteen adversarial R.M.C. 806(b)(2) hearings in this case. Only one R.M.C. 806(b)(2) hearing transcript has been redacted and released to the public despite military commission orders to the contrary.
- b. In 2017, the parties filed ninety-six classified documents in this case. The government has not released redacted versions of any of these pleadings to the public.
- c. In 2017, the government did not release one hundred ninety-seven unclassified filings to the public at all. The government withheld an additional three hundred fifteen unclassified filings for more than thirty days from the time of filing.

**6. Argument:**

Mr. al Baluchi has been denied a public trial in this case. The general public is severely limited in its ability to actually view the proceedings. It has two choices: (1) travel and gain access to the Fort Meade Post Theater remote viewing site; or (2) be granted one of the exceptionally limited opportunities to watch from the courtroom gallery at Naval Station, Guantanamo Bay, Cuba. As a result, the public must rely on the mc.mil website in order to follow the trial. However, the documents available on the website fail to adequately inform the public. Classified documents are not redacted and released. Unclassified documents are either not released at all, or not released in a timely manner. The cumulative effect is a trial that is not open to the public.

**a. The government failed to redact and release to the public each of the 96 classified documents filed in 2017.**

Regulation for Trial by Military Commission (RTMC) §§ 17-1 and 19-4 require the release of redacted versions of filings containing classified information. Title 10 U.S.C. § 949d(c)(2) limits the ability of the military commission to order closure to situations involving risks to national security or physical safety. Consistent with this statute, RTMC § 19-1 requires the military commission to “provid[e] access to military commission proceedings, transcripts, pleadings, filings, rulings, orders and other materials used at military commission proceedings, to the extent that these materials are not classified, covered by a protective order, or otherwise protected by law, including the rules and regulations governing military commissions.”

After filing of a pleading involving classified information, RTMC § 17-1(c)(3)(A) requires the DoD Security Classification/Declassification Review Team to “review and make appropriate redactions as necessary to render the material suitable for public posting. This process will ensure the redaction of all classified or otherwise protected information implicating a department or

agency's equities." RTMC § 19-4(c)(2) requires that this review shall take no longer than 15 business days unless extended upon notification of exceptional circumstances.

Following security review, both Chapters 17 and 19 require public release of redacted versions of pleadings. RTMC 19-4(c)(2) requires that, "All other filings and others [requiring security review] shall be publicly released after the DoD Security Classification/Declassification Review Team and/or the appropriate non-DoD federal department and agency original classification authority confirms to the commission that such filings and orders are in publicly releasable form." RTMC 19-4(b) defines releasable form as versions of filings, opinions and orders "that contain no classified or protected information, or from which all such information has been redacted by the DoD Security Classification/Declassification Review Team and/or the pertinent non-DoD federal department and agency." Finally, RTMC 17-1(c)(4) provides, "Once a filing is deemed to be publicly releasable, the public releasable version shall be posted on the OMC website unless the military judge articulates some other basis for it to remain under seal, consistent with the statutes, rules and regulations governing military commissions."

In 2012, Mr. al Baluchi filed a motion requesting the military commission to order compliance with RTMC §§ 17-1(c)(4) and 19-4(c)(2).<sup>6</sup> The military commission granted the motion and ordered the government "to comply with its own regulations, specifically [RTMC] paragraphs -- or Chapters 17 and 19."<sup>7</sup> The military commission's order has not been followed.

In 2017, for example, at least 96 classified documents were filed.<sup>8</sup> Not one has been redacted and released to the public.


**b. The government has failed to timely release to the public unclassified filings.<sup>9</sup>**

RTMC § 19-4 also addresses unclassified filings. It states, “Filings and orders that do not require classification security review under Chapter 17-1 shall be posted within one business day of filing with the military commission.” RTMC § 19-4(c)(1). Far from following the one business day requirement, the majority of unclassified filings in 2017 were not posted until more than twenty (20) days had elapsed from the date of filing. Twenty-six (26) filings were not posted until more than one hundred (100) days had elapsed. And alarmingly, one hundred ninety-seven

(197) filings were never posted at all. The chart below shows the various delays in unclassified filings being posted to the mc.mil website in 2017.



**c. The government has failed to redact and release to the public all but one of the R.M.C. 806(b)(2) hearing transcripts in this case.**

According to the Office of Court Administration, there have been a total of 16 adversarial R.M.C. 806(b)(2) hearings.<sup>10</sup> In each instance the military commission ordered a redacted, unclassified transcript of the closed session to be prepared expeditiously and provided to the public in a similar manner as the unauthenticated transcripts of open sessions.<sup>11</sup> The government

complied with the military commission's order one time.<sup>12</sup> The 15 remaining R.M.C. 806(b)(2) hearing transcripts remain hidden from the public.

**d. The military commission should dismiss the charges for failure to provide a public trial.**

The Sixth Amendment to the United States Constitution guarantees an accused the right to a public trial in all criminal prosecutions.<sup>13</sup> The Supreme Court has held that violations of a defendant's Sixth Amendment right to a public trial is structural error that does not require a showing of harm.<sup>14</sup> Moreover, the Court has held that the right to a public trial was created for the benefit of the accused; thus the right is a personal one.<sup>15</sup>

As one element of a public trial, the public has a “right to inspect and copy public records and documents, including judicial records and documents.”<sup>16</sup> The right to access includes pleadings which form the basis for a judicial decision, including the exhibits submitted in support of those pleadings.<sup>17</sup> The practice of withholding in their entirety pleadings and transcripts which contain any classified information violates these principles of open access. The government has no good, much less compelling, reason to completely withhold pleadings and transcripts because some aspect of them is classified. Redaction of classified information is sufficient to fully satisfy the government’s interest in protecting classified information.<sup>18</sup> Although documents containing classified information must be marked classified, security review and redaction removes the classified information and brings the redacted pleadings into the public sphere.

The D.C. federal courts have repeatedly rejected government attempts to withhold unclassified information regarding prisoners at Guantanamo Bay. First, in *Bismullah v. Gates*, the D.C. Circuit rejected a government proposal that the government could unilaterally determine whether unclassified information should be sealed.<sup>19</sup> The D.C. Circuit held that “insofar as a party seeks to file with the court nonclassified information the Government believes should be ‘protected,’ the Government must give the court a basis for withholding it from public view.”<sup>20</sup> Second, in *Parhat v. Gates*, the D.C. Circuit rejected a government proposal to redact all

“identifying information of United States government personnel” and “sensitive law enforcement information,” holding that the government must individually justify redactions of unclassified information.<sup>21</sup> Finally, in *In re Guantánamo Bay Detainee Litigation*, the D.C. District Court rejected a government proposal to seal all factual returns, requiring instead that the government file highlighted copies identifying and explaining its proposed redactions.<sup>22</sup>

The failure to provide meaningful public access to the military commission proceedings, including its pleadings, violates Mr. al Baluchi’s constitutional and statutory right to a public trial. Over five years ago, the military commission ordered the government to comply with its own regulations, but the government has refused to do so. The military commission has no remaining recourse other than to order dismissal of the charges as a sanction.

**7. Oral Argument:** Mr. al Baluchi respectfully requests oral argument.
