INTERIM ORDER

Defense Motion to Conduct Thorough Inquiry into Actual and/or Potential Attorney Conflict of Interest Pursuant to R.M.C. 901 and *Holloway v. Arkansas*, 435 U.S. 475 (1978) and to Cancel Proceedings Pending Inquiry.

22 January 2019

1. Procedural Background.

a. Defense Counsel for Mr. bin 'Attash filed AE 615 (WBA)¹ requesting the Commission conduct a thorough inquiry into the potential conflict they claim results from an investigation being conducted by the Federal Bureau of Investigation (FBI) involving at least a former paralegal. Counsel for Mr. bin 'Attash asserted "Mr. bin 'Attash's Defense Team is under investigation by the Federal Bureau of Investigation."² Thereafter, Counsel for Mr. Mohammad filed AE 615A (KSM) requesting all briefing schedules be suspended pending the resolution of AE 615 (WBA). Counsel for Mr. bin 'Attash filed three (3) Notice[s] of Conflict Affecting Representation of Mr. bin 'Attash's Interests in Filing Pleadings as to the AE 614, AE 616 and AE 530 series.³ Counsel for Mr. Mohammad also filed notices of declination to file pleadings in AE 555, AE 614, and AE 616 because of the alleged "presumptive" conflict of interest involving all of the Defense Teams.⁴

b. In response to the Commission's order for an expedited briefing schedule,⁵ the Government Special Trial Counsel (STC) filed AE 615D (GOV SRT)⁶ asserting there was no conflict of interest burdening any of the five (5) defense teams as there is no investigation of any "counsel of record" or "known current member" of the bin 'Attash defense team pending. This assertion was supported by a declaration of a FBI Supervisory Special Agent stating that, after searching the FBI's official system of records, he was aware of no information that any counsel of record or member any of the five defense teams is currently under FBI investigation.⁷

2. **Analysis.** The Commission appreciates the information the STC provided via the FBI Supervisory Special Agent's declaration. However, the Commission recognizes the Defense teams have not yet filed any replies to the STC pleading and declaration and the next session of Commission hearings is scheduled to begin on 28 January 2019 at U.S. Naval Station, Guantanamo Bay, Cuba. In order to conduct the thorough inquiry into the potential conflict requested by Mr. bin 'Attash's counsel, the Commission finds it necessary to require the STC to provide the Commission an *ex parte* presentation to further illuminate the facts and circumstances of the FBI investigation.

3. **ORDER.** At least one member of the STC will appear and provide the Commission a robust presentation on the facts and circumstances surrounding the FBI investigation and what additional investigative steps, if any, are contemplated. The presentation will be *ex parte* in nature. The transcript and any exhibits received by the Commission as part of the *ex parte* presentation will be maintained under seal. The presentation will be conducted in the secure space controlled by the
