Time to File a Reply to AE 625A (GOV)

Filed: 30 April 2019

1. **Timeliness:** This motion is timely filed.
2. **Relief Sought:** Mr. al Hawsawi requests a one week extension, until 10 May 2019, to file a Reply to AE 625A (GOV).
3. **Burden of Proof:** The defense bears the burden of persuasion on the underlying motion.
4. **Facts:**
 - a. On 12 April 2019, Mr. al Hawsawi filed AE 625 (MAH), Defense Motion to Dismiss Because the Military Commissions Act of 2009 Is a Bill of Attainder.
 - b. On 26 April 2019, the government filed AE 625A (GOV), Government Response To Defense Motion to Dismiss Because the Military Commissions Act of 2009 Is a Bill of Attainder.
5. **Argument:** The current deadline to file a reply to AE 625A (GOV) is 3 April 2019. However, this session of the Military Commissions is scheduled for 29 April to 3 May 2019. Thus, Mr. al Hawsawi respectfully requests an extension of seven days, until 10 May 2019, to file his reply.
