- 1. Procedural History. On 16 August 2019, Mr. bin' Attash moved the Commission to "compel
- ... Mr. Christian Reismeier and Mr. Jason Foster as witnesses" in support of his 9 July 2019 motion to disqualify Mr. Reismeier as Convening Authority. The Government responded to the motion to compel on 30 August 2019, and Mr. bin 'Attash replied on 6 September 2019. The parties argued the matter before the Commission on 7 November 2019.

2. **Law**.

a. **Burden of Proof**. As moving party, the Defense bears the burden of proving any facts prerequisite to the relief sought by a preponderance of the evidence.⁵

b. Witness Production. The Defense "shall have reasonable opportunity to obtain

witnesses and other evidence," to include "production of any available witness whose testimony

on a matter in issue on the merits or on an interlocutory question would be relevant and

necessary."7

3. **Analysis**. Based on the filings and argument of the parties, and the contents of certain past

communications made by Mr. Reismeier (referenced by the Defense in oral argument), the

Commission concludes the Defense has met its burden to show the testimony of Mr. Reismeier

to be relevant and necessary to resolution of the motion to disqualify him. Accordingly, the

Commission will direct his production. The Commission further concludes ruling as to

Mr. Foster's production would be premature at this time, as Mr. Reismeier's testimony may be

material to that decision. The motion will therefore be deferred as to Mr. Foster.

4. **Ruling**. The motion is **GRANTED** as to Mr. Reismeier, and **DEFERRED** as to Mr. Foster.

5. **Order**. The Government shall produce Mr. Reismeier to testify before the Commission at a

date and time to be directed in a future docket order.

So **ORDERED** this 18th day of November, 2019.
