1. On 6 September 2019, pursuant to the Commission's Order in AE 133H,¹ the Government moved² *ex parte* to request permission to install a Teletype Machine in Courtroom #2.

2. Ruling.

a. The Government request to file this motion *ex parte* is **GRANTED**.³

b. The Government motion requesting permission to install a teletype machine in Courtroom #2 is **GRANTED**.⁴

3. **Order.** Under no circumstances will any teletype machine or other device installed by any Government entity in Courtroom #2 have capability to access or monitor any Defense attorney-client privileged communications.

4. The Government's classified, *ex parte*, and in camera motion and draft shall remain *ex parte* and in camera until further order of this Commission.
