1. This Order amends the AE 950 Docket Order series,¹ to adjust the schedule for the second week of the **15 July – 9 August 2024** hearing session at U.S. Naval Station, Guantanamo Bay (NSGB), Cuba by substituting an available witness for an unavailable witness,² scheduling the resumption of open sessions for **0900 on Thursday, 25 July 2024**, adding two pending motions for oral argument,³ and authorizing the use of Courtroom #2 and areas adjacent to the courtroom by Defense teams during certain periods when the Commission is in recess.

2. Accordingly, AE 950 is modified as follows:

a. Paragraph 5.a.(2) is amended, to read:

(2) Special Agent (SA) Maria Jocys, FBI (Retired), testifying from NSGB

Courtroom 2 on or about 25 – 26 July 2024;

b. Paragraph 6 is amended to add:

g. AE 942MM (AAA) – Mr. al Baluchi’s Motion to Compel Discovery Relating to Testimony of Kimberly Waltz and Aaron Zebley; and

h. AE 930 (KSM) - Mr. Mohammad's Motion to Compel Regarding Activities and Records.

c. Paragraph 11 is amended to read:

a. The Commission finds it is in the interest of justice for the Accused not to be restrained when they are meeting with members of their Defense Teams in the courtroom or in areas adjacent to the courtroom from 14 July 2024 – 9 August 2024. Accordingly, they are to be unshackled during such meetings.⁴

b. To the extent any Defense Team wishes to meet with their client in Courtroom #2 or in areas adjacent to the courtroom during any weekday partial or full day recess⁵ (and for up to one hour after the Commission recesses for the evening), the Commission authorizes such use.⁶

3. The remainder of the Docket Order remains unchanged.

⁴ In the event the Commander, Joint Task Force – Guantanamo Bay, or his designee come into the possession of information raising specific force protection concerns in regard to a particular Accused that would necessitate that Accused being restrained during legal meetings in the courtroom or the adjacent areas, the Commander or his designee shall immediately inform the Military Judge through the CISO.
